ABSTRAK

Tesis ini menganalisis kapabiliti pertahanan nasional Jepun terhadap kemungkinan serangan senjata nuklear dan peluru berpandu Korea Utara dan China serta implikasi ke atas keselamatan Jepun. Di samping itu tesis ini menilai dasar keselamatan Jepun berpaksikan dua tunggak utama iaitu, 'kapabiliti pertahanan minimum yang sederhana' dan 'integriti Perikatan Keselamatan Jepun-Amerika Syarikat'.

Tesis ini menghujah *Japan's self-imposed constraints on militarism* berhadapan dengan proses pengubahsuaian secara beransur-ansur akibat tekanan keselamatan oleh Korea Utara dan China. Walau bagaimanapun tesis ini menolak andaian teori neorealisme yang menghujah Jepun akan kembali menjadi kuasa tentera dalam masa terdekat sebaliknya berpendapat andaian realisme pasca klasik lebih realistik dan dominan dalam menilai pertahanan nasional Jepun kontemporari. Walaupun integriti pasifisme semakin dicabar tetapi dasar pertahanan Jepun ke arah *normal state* berhadapan dengan dilema ekoran kekaburan interpretasi ke atas Perlembagaan. Kerajaan Jepun menegaskan bahawa dalam berhadapan dengan bentuk-bentuk ancaman *imminent* dan *illegitimate* peluru berpandu musuh ke atas wilayah Jepun, adalah tidak wajar jika Perlembagaan Jepun tidak membenarkan langkah-langkah pencegahan atau serangan balas diambil. Walaupun *Diet* membuat ketetapan adalah perlu untuk maksud mempertahankan keselamatan negara, mengambil langkah yang melampaui 'kapabiliti pertahanan minimum yang sederhana' namun ia lebih merupakan retorik pembuat undang-undang bagi meredakan ketegangan sementara yang muncul. Persoalan pertahanan nasional Jepun menjadi semakin kompleks apabila Korea Utara serta China membangunkan kapabiliti nuklear dan peluru berpandu yang mencabar keselamatan Jepun dalam situasi ketidakjelasan interpretasi perlembagaan tersebut.

Tesis ini menghujah Jepun tidak mempunyai pilihan selain mendefinisikan semula dasar pertahanan dan Perjanjian Keselamatan Jepun-Amerika Syarikat. Ia disebabkan mekanisme keselamatan multilateral dalam konteks Asia adalah tidak *applicable* untuk direalisasikan dinilai dari perspektif persekitaran keselamatan kontemporari dan sejarah Asia Timur. Sekalipun kumpulan pendesak yang menyarankan Jepun menjadi *normal state* menolak untuk bergantung kepada perlindungan keselamatan dan nuklear Amerika Syarikat selama-lamanya, namun tesis ini menyimpulkan pertahanan nasional Jepun akan terus dipengaruhi oleh faktor-faktor domestik dengan pergantungan kuat ke atas Dasar Keselamatan Jepun-Amerika Syarikat.

ABSTRACT

This thesis analyses Japan's defense capability over the possibility of a nuclear and missiles strike from North Korea and China as well as its implications towards Japan's security posture. In addition, it also evaluates Japan's security policies based on two major considerations namely 'a moderate defense capability' as well as 'the integrity of the Japan-United States Security Alliance.'

This thesis argues that Japan's self-imposed constraints on militarism are currently faced with a gradual process of change mainly due to pressures from North Korea and China. However, this works rejects the neo-realists notion that Japan would emerge as major military power in the near future but instead argues that the assumptions of the post-classical realists appear to be more realistic and dominant in order to evaluate Japan's contemporary defense posture. Although the integrity of pacifism is constantly being challenged, the movement of Japan's defense posture to a 'normal state' is also faced by the dilemma of vagueness in interpreting Japan's constitution. The Japanese government has reiterated that in facing imminent and illegitimate missile threats towards Japanese territory, it is inconceivable that the country's constitution disallows for preventive measures or even a counter attack. Although the Japanese Diet itself made a resolution that allows for measures that exceed 'the moderate defense capability' currently followed, all this however, has remained much of a rhetoric amongst Japanese law makers, who rather take temporary measures in diffusing external threats. The question of Japan's defense posture remains complex especially in view of the development of their respective nuclear capabilities by North Korea and China that continues to challenge Japan's security posture especially in an environment shadowed by an unclear interpretation of the country's constitution.

This thesis also argues that Japan is currently faced with the need to redefine its defense posture as well as its defense treaty with the United States. This because the mechanisms of multilateral security in the context of Asia are inapplicable for realization especially when evaluated within the context of contemporary perspectives on the current security environment and the history of the East Asian region itself. Although various groups that continue to call for Japan's return to a 'normal state' have rejected the security and nuclear shield provided by the United States, this thesis concludes that domestic factors and a strong reliance on the Japan-United States Alliance will continue to shape Japan's defense posture, at least in the near future.

BAB 1

PENGENALAN

1.0: Pendahuluan

Dasar pertahanan yang dibentuk selepas tamat Perang Dunia Kedua berjaya mengekalkan keamanan dan keselamatan Jepun walaupun tercetus konflik ketenteraan dan elemen keganasan yang tidak dijangka di beberapa wilayah dunia yang mengakibatkan ketidakstabilan antarabangsa.¹ *Defense of Japan 2003* menegaskan kebarangkalian berlakunya serangan musuh yang besar ke atas Jepun amat tipis tetapi menjangkakan wujud ancaman keselamatan ke atas Jepun akibat bertambahnya kuantiti *Weapons of Mass Destruction* (WMD) dan aktiviti-aktiviti pengganas.² Jangkaan tersebut berdasarkan senario keselamatan Asia Timur yang tidak stabil, sebahagian besar akibat ancaman senjata nuklear dan peluru berpandu Korea Utara dan China ke atas keselamatan Jepun. Ujian senjata nuklear China yang dilakukan secara berterusan, ujian peluru berpandu balistik Taepodong-I Korea Utara pada tahun 1998 serta pengakuan Pyongyang memiliki senjata nuklear pada September 2002, menyebabkan Jepun menilai semula kapabiliti pertahanan yang dimiliki.³ Sehubungan itu, dasar pertahanan
