The main objective of adopting ICT in most country is to boost the economical status of the rural area dwellers that could be mediated by their ICT technological know-how. this study develop an electronic evaluating and monitoring system, to eradicate the time consuming deficiencies in the physical evaluation, and to help in overcoming the inconsistence and low productivity in the paper evaluation of ICT training in Rural Area.
